To establish the Grand Village of the Natchez Indians and Jefferson College as affiliated areas of the Natchez Historical Park, and for other purposes.

- SECTION 1. SHORT TITLE.

- SEC. 2. DEFINITIONS.

1	(1) Affiliated Area.—The term "affiliated
2	area" means an affiliated area of the Park estab-
3	lished by section $3(a)(1)$.
4	(2) Management entity.—The term "man-
5	agement entity" means the management entity for
6	the affiliated areas designated by section 3(d).
7	(3) Park.—The term "Park" means the
8	Natchez National Historical Park.
9	(4) Secretary.—The term "Secretary" means
10	the Secretary of the Interior.
11	SEC. 3. ESTABLISHMENT OF AFFILIATED AREAS.
12	(a) Establishment.—
13	(1) In general.—On a determination by the
14	Secretary that the sites described in paragraph (2)
15	meet the criteria for designation as an affiliated
16	area, the sites are established as affiliated areas of
17	the Park to preserve, protect, and interpret for the
18	benefit of present and future generations resources
19	associated with the sites.
20	(2) Description of sites.—The sites referred
21	to in paragraph (1) are—
22	(A) the Grand Village of the Natchez Indi-
23	ans, which is a National Historic Landmark
24	and is listed on the National Register of His-

1	(B) Jefferson College, which is listed on
2	the National Register of Historic Places.
3	(b) Map.—
4	(1) In general.—As soon as practicable after
5	the date of establishment of the affiliated areas, the
6	Secretary shall prepare a map depicting the bound-
7	aries of the affiliated areas.
8	(2) AVAILABILITY.—The map prepared under
9	paragraph (1) shall be on file and available for pub-
10	lic inspection in the appropriate offices of the Na-
11	tional Park Service.
12	(c) Administration.—The affiliated areas shall be
13	managed in accordance with—
14	(1) this Act; and
15	(2) any law generally applicable to units of the
16	National Park System.
17	(d) Management Entity.—The Mississippi Depart-
18	ment of Archives and History shall be the management
19	entity for the affiliated areas.
20	(e) Cooperative Agreements.—The Secretary
21	may provide technical assistance to, and enter into cooper-
22	ative agreements with, the management entity for the pur-
23	pose of providing financial assistance for the marketing
24	marking, interpretation, and preservation of the affiliated
25	areas.

1	(f) Limited Role of the Secretary.—Nothing in
2	this Act authorizes the Secretary—
3	(1) to acquire property at the affiliated areas
4	or
5	(2) to assume financial responsibility for the
6	operation, maintenance, or management of the affili-
7	ated areas.
8	(g) Management Plan.—
9	(1) In General.—The Secretary, in consulta-
10	tion with the management entity, shall develop a
11	general management plan for the affiliated areas in
12	accordance with section 100502 of title 54, United
13	States Code.
14	(2) Submission.—Not later than 3 years after
15	the date of establishment of the affiliated areas, the
16	Secretary shall submit the management plan devel-
17	oped under paragraph (1) to—
18	(A) the Committee on Energy and Natura
19	Resources of the Senate; and
20	(B) the Committee on Natural Resources
21	of the House of Representatives.
